ENTRY

FEE

We ask that within the first 60 days of our collaboration that you provide GreyMob with \$250 to provide working capital, and as a gesture of your commitment. We encourage you to raise this entry fee from friends and family. If your application is accepted and you are named a GreyMob Fellow, our work to come alongside you and your idea will be scholarshiped by our generous GreyMob donors and sponsors.

Our desire is to design and stimulate ventures that can do some good in the world around us. We want your idea to succeed even beyond the scope of our involvement.

INTELLECTUAL PROPERTY - SPINNING OUT

All Intellectual Property, including but not limited to copyrights, trademarks, patent rights, trade secrets and know-how, brought to the collaboration or created as part of the collaboration shall be considered jointly owned by GreyMob and you.

Within 90 days after the formal completion date of the collaboration, you have the option to complete an Exit Agreement to spin out from this collaboration and take all the Intellectual Property with you for the purpose of exclusively pursuing a venture to commercialize our collaboration.

If you don't complete an Exit Agreement and turn it in within these 90 days after formal completion date of the collaboration, GreyMob may exclusively pursue further development and commercialization of the collaboration, including but not limited to the Intellectual Property.

DILIGENT PROGRESS

If you spin out your venture you must demonstrate, when asked, to GreyMob's satisfaction that you are continually making diligent efforts to develop the venture. Failure to demonstrate diligent efforts to develop the venture for any continuous 12 month period may result in GreyMob exclusively pursuing further development and commercialization of the collaboration, including but not limited to the Intellectual Property.

REVENUE RIGHTS

If you spin out a venture and it or the related Intellectual Property is able to make some revenue, you agree to annually pay GreyMob 3% of the annual gross receipts generated after it first starts generating revenue. Additionally, if the venture or the related Intellectual Property that is spun out of GreyMob has an exit event, either through the sale of more than 50% of its stock or the sale of more than 50% of its assets, then you will pay GreyMob a one time fee equal to 10% of the gross exit value. GreyMob has the first right of refusal to this sale.

ADDITIONAL LEGAL DOCUMENTS

If either party spins out the Intellectual Property a more detailed contract or license may be developed to be consistent with this agreement and executed by all the parties to this agreement.
